I · Purpose



In order to strengthen the management of the Company's intellectual property rights, to protect the Company's intellectual property, and to reduce operational risks and improve operational efficiency, this management plan is formulated in accordance with the Patent Law, Trademark Law, Trade Secret Law and other laws and regulations related to intellectual property management.

So far, the work points have been promulgated and implemented. Regarding colleagues' illegal reproduction of information that should be kept confidential and deliberate deletion, tampering, and leakage of customer information before leaving the Company, the business units have reported and been investigated and confirmed by the customer service department and the legal office. In 2023, 2 cases were investigated and confirmed. 7 cases were investigated and confirmed in 2024, all of which were severely punished or dismissed, and colleagues were held legally responsible. In the future, we will continue to educate the personnel of each applicable entity of the Group.
